This closed policy workshop on irregular migration and asylum is a joint initiative of the Konrad-Adenauer-Stiftung Athens office (KAS) and the Hellenic Foundation for European and Foreign Policy (ELIAMEP). The workshop aims at a rapprochement of views among Greece and Turkey, offering perspectives from Germany and highlighting the EU dimension, in respect to the potential for improving the management of irregular migration and asylum flows. It will focus on the evolving situation at the Greek-Turkish borders, the existing patterns of cooperation and the prospects for the future, the migration and asylum nexus, the Greek policy and administrative experiences of dealing with immigration and asylum, the labor market implications and shifting pathways to irregularity at a time of crisis. The workshop will involve academics, policy makers and practitioners who specialize in various aspects of the above topics.
