- 12. Any leader who has been dismissed or forced to resign after being proven to be in violation of Leadership Ethics; should neither be ever appointed to any leadership position nor be ever nominated to a leadership position
- 13. The Constitution should recognize the role to be played by a council of religious leaders and other community elders in advising the government on legislation, social and other sensitive national issues
- 14. The Ethics Commission shall have the obligation to provide proof of integrity of any leader lined-up for election or nomination before other processes take-off.

- 9. Any agreement / relationship between a member state to the Union and any third party; should ensure the Union is not compromised in any way
